HISTORY OF PRESENT ILLNESS AND HOSPITAL COURSE

The patient is an 81-year-old Caucasian male with recent suprapubic prostatectomy on 06/22/2011, who was recently restarted on his Pradaxa approximately 1 week prior to admission. The patient began having profuse bleeding from his genitourinary tract as well as hypotension with blood pressure in the 60s over 30s. The patient was transferred to the emergency room, intubated, given TVF, and started on both dopamine and Levophed. The patient was then transferred to the ICU. In the ICU a Quenton was placed as well as transducer for rapid volume resuscitation and the patient underwent dialysis to help remove the Pradaxa from his blood. The patient remained maxed on all pressors and was given 12 units of packed red blood cells, 12 units of FFP, 2 super packs of platelets, three 10 packs of cryoprecipitate, 3 doses of factor VII as well as aminocaproic acid. all this, the patient's hemoglobin continued to fall, and the patient's blood pressure continued to remain low. After discussion with the family, it was decided the family would be made DNR and withdrawal of care would be provided. The patient passed away on 07/14/2011 at approximately 7:00pm.
